**CREATING THE BUSINESS DEVELOPMENT AND PROMOTIONS COMMITTEE**

WHEREAS, the City Government of Angeles thru its City Council has approved Ordinance No. 434, Series of 2017 or the Angeles City Local Investment and Incentive Code of 2017;

WHEREAS, Ordinance No. 434, Series of 2017, Chapter IV, Angeles City Economic Development and Investment Promotions Office, Section 12 states that "The Local Economic Development and Investment Promotions Office of the city shall be known as the Angeles City Economic Development and Investment Promotions Office (ACEDIPO). The ACEDIPO shall be the lead office on investments promotions and in carrying out the objectives of the Code;

WHEREAS, Chapter IV, Section 13i, Functions of the ACEDIPO, states that "The ACEDIPO shall serve as the Technical Secretariat of the Board and shall take an active role in implementing the Code. It shall perform the following functions: Establish cooperative undertakings with other LGUs, private sector, NGOs, NGAs and other institutions as may be necessary, useful and incidental to the effective and efficient implementation of the ACIIC";

WHEREAS, the city government recognizes the important and unique role of local agencies in the unified development and promotion of businesses in the city;

NOW, THEREFORE, in view of the foregoing, I, Edgardo D. Pamintuan, City Mayor of Angeles City, by virtue of the powers vested in me by the Local Government Code of 1991 and other laws of the Philippines, do hereby order the following:

**SECTION 1. Creation of the Business Development and Promotions Committee (BDPC).**

The BDPC shall be composed of the following local government offices:

**SECTION 2. Functions.** The BDPC shall have the following functions:


1. Formulate programs, projects and activities that will be supportive and in harmony with the attainment of the economic development and investment promotions activities of the city;
2. To recommend policies/strategies that will ensure the sustainable growth and development of identified businesses and industries in the city;
3. To conduct regular meetings in order to address issues and concerns related to the implementation of economic and investment programs and activities.

**SECTION 3. Meetings and Budget.** The budget for the implementation of the programs shall be charged to available funds subject to usual accounting and auditing rules and regulations. All expenses and disbursements shall be properly documented and accounted for.

**SECTION 5. Repeal Clause.** This Executive Order supersedes all previous issuances inconsistent herewith.

**SECTION 6. Effectivity.** This Order takes effect immediately.
