**Creating the Angeles City Task Force on Culinary Inspection (AC-TFCI)  
and Other Related Matters**

WHEREAS, the Regional Development Council's Special Committee on Tourism has decided that the primary tourism focus of the Province of Pampanga and the City of Angeles is the promotion of the province as the culinary center of the region;

WHEREAS, Angeles City aims to become the Culinary Capital not only of Central Luzon but of the entire island of Luzon and the country as well;

WHEREAS, one of the requirements to being the Culinary Center of the region and the country is the existence of world class restaurants in Angeles City;

WHEREAS, to be world class these restaurants must not just cater to excellent cuisines but must also be perfect in following sanitary standards, from the kitchens and food preparation areas to its dining rooms, and even its restrooms;

WHEREAS, there have been some reports of unsanitary practices by some restaurants and an unfortunate food poisoning episode allegedly from a well-know buffet restaurant;

WHEREAS, these reports must be properly and immediately addressed;

NOW, THEREFORE, I, Edgardo D. Pamintuan, Mayor of Angeles City, by the powers vested in me by the Local Government of the Philippines and other pertinent laws, rules and regulations, do hereby declare the following:

Section 1. Creation of the Task Force Angeles City Task Force on Culinary Inspection (AC-TFCI). – The Angeles City Task Force on Culinary Inspection or ACT-TFCI is hereby created directly under the Office of the City Mayor.

Section 2. Composition and Functions of AC-TFCI. - The AC-TFCI shall be composed of the following:

The Task Force shall have the following functions:

- Orient owners and staff of hotels, restaurants, cafes and similar establishments within the city on the focus of the City Government of Angeles relative to tourism;
- Conduct inspection of food establishments;
- Recommend measures against violators of sanitation and other safety standards; and,
- Perform other functions as directed by the City Mayor.

Section 3. Assistance from Other Departments and Offices. - The Task Force may tap the assistance of other departments and offices of the City Government of Angeles in the performance of its functions. All officials and personnel of the City Government of Angeles are directed to give full support to the Task Force.

Section 4. Effectivity. - This Order takes effect immediately and supersedes other measures, rules and regulations inconsistent herewith.
