**DESIGNATING THE ANGELES CITY COOPERATION TECHNICAL WORKING GROUP TO FACILITATE
THE ECONOMIC, TRADE AND TOURISM COOPERATION AGREEMENT WITH BAGUIO CITY**

WHEREAS, Article X, Section 13 of the Philippine Constitution declares that "Local Government Units may group themselves, consolidate or coordinate their efforts and resources for the purpose commonly beneficial to them in accordance to the law";

WHEREAS, Section 33 of the Local Government Code of 1991 states "This allows for Inter-LGU cooperation to occur through Memoranda of Agreement for mutually beneficial purposes, with agreed contributions of staff, financial and capital resources in whatever manner that suits the LGU concerned";

WHEREAS, Angeles City has entered into an Economic, Trade and Tourism Cooperation agreement with the City of Baguio through a Memorandum of Agreement on April 25, 2018;

WHEREAS, the Memorandum of Agreement on Economic, Trade and Tourism Cooperation provides for the creation of the Angeles-Baguio Cooperation Technical Working Group (ABC-TWG) that shall be composed of representatives from both cities to be co-chaired by both and to be assisted by four (4) members from each city.

NOW, THEREFORE, I, Edgardo D. Pamintuan, Mayor of Angeles City, by the powers vested in me by Republic Act No. 7160 otherwise known as the Local Government Code of 1991 do hereby order.

SECTION 1. THE ANGELES CITY COOPERATION TECHNICAL WORKING GROUP (ACC-TWG) – The Angeles City Cooperation Technical Working Group is hereby designated to facilitate the implementation of the Economic, Trade and Tourism Cooperation with the City of Baguio as provided in the Memorandum of Agreement. The ACC-TWG is composed of the following:

SECTION 2. DUTIES AND RESPONSIBILITIES OF THE ANGELES CITY COOPERATION TECHNICAL WORKING GROUP.
The ACC-TWG shall have the following duties and responsibilities:

- a. Develop cooperation projects that will promote policy and program exchanges in economics, trade and tourism in both cities;
- b. Facilitate the implementation the approved projects through close coordination and cooperation;
- c. Manage funds that will be allocated for the implementation of cooperation projects;
- d. Identify revenue generating projects that may be implemented in both cities;
- e. Promote tourism and cultural exchanges and local products;
- f. Partner in the conduct of trade and investment missions locally and abroad.

SECTION 5. MEETINGS AND BUDGET.


The ACC-TWG shall meet regularly with its counterpart from the City of Baguio either in Angeles City or Baguio City. The Angeles City government shall appropriate the funds necessary for the implementation of the approved programs and projects of the Angeles-Baguio Cooperation Technical Working Group.

SECTION 6. EFFECTIVITY – This Order takes effect immediately.
