**Reorganizing the Fiestang Kuliat Committee and
For Other Related Purposes**

WHEREAS, one of the priority programs of the City Government of Angeles is the development of Angeles City as the Tourism Capital of Central Luzon;

WHEREAS, in order to realize this vision, Angeles City needs to organize significant events that will place the city on the national and international tourism roadmap;

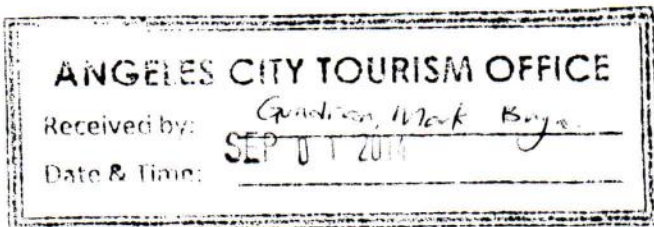
WHEREAS, one such event is the annual Fiestang Kuliat which is a month-long celebration that culminates in the well-known Tigtingan Terakan keng Dalan (TTKD) Festival;

WHEREAS, there is a need to create committees in order to ensure the success of the annual celebration of Fiestang Kuliat;

NOW, THEREFORE, by the powers vested in me by law, I, Edgardo D. Pamintuan, Mayor of Angeles City, do hereby order the following:

SECTION 1. CREATION OF THE FIESTANG KULIAT COMMITTEE. – The Fiestang Kuliat Committee is hereby created and shall be composed of the following:

SECTION 2. FUNCTIONS OF THE FIESTANG KULIAT COMMITTEE. - The Fiestang Kuliat Committee shall have the following functions:

1. Organize all necessary activities before, during and after the Fiestang Kuliat;
2. Conduct information dissemination and related undertakings;
3. Ensure the active cooperation and participation of individuals, groups, organizations and corporations;
4. Conduct activities to mobilize resources and logistics; and,
5. Perform other related actions needed to ensure the success of the Fiestang Kuliat.

SECTION 3. COMMITTEE SECRETARIAT. - The Angeles City Tourism Office (ACTO) and the City Information Office (CIO) shall serve as the Secretariat of the Fiestang Kuliat Committee. Additional members of the Secretariat may be designated/ appointed by the Chairman upon the recommendation of the members of the Committee.

SECTION 4. DONATIONS. - Subject to the provisions of the Local Government Code and other laws and regulations, the City Government may accept donations from private organizations, corporations or individuals for the Fiestang Kuliat project.

SECTION 5. TICKET SALES AND OTHER INCOME. - Subject to the provisions of the Local Government Code and other pertinent laws, the committee may sell tickets and generate other forms of income in all events during the celebration of Fiestang Kuliat.

SECTION 6. GENERAL FUND. - All donations and proceeds from ticket sales and other related income shall form part of the General Fund of the City Government, and shall be used for Fiestang Kuliat activities and other city events subject to pertinent laws and guidelines. Purportedly, a Special Fund within the General Fund is hereby created.

SECTION 7. BUDGET. - The budget needed for the operational needs of the Fiestang Kuliati Committee may be charged to available funds subject to government accounting and auditing rules and procedures.


SECTION 8. REPEAL CLAUSE. - This Executive Order supersedes all previous issuances inconsistent herewith.

SECTION 9. EFFECTIVITY. - This Executive Order shall take effect immediately.
