**CREATING OF THE ANGELES CITY TOURISM COUNCIL (ACTC)
AND OTHER RELATED PURPOSES**

WHEREAS, the Angeles City Tourism Council (ACTC) shall serve as the policy making body of the City Government in formulation of programs for the development, promotion and supervision of tourism in collaboration with the Department of Tourism, the Philippine Tourism Authority and other agencies, persons, or entities concerned with Tourism;

WHEREAS, the Angeles City Tourism Council (ACTC) shall promote to the development of areas with potential tourism value, otherwise known as "tourist zones";

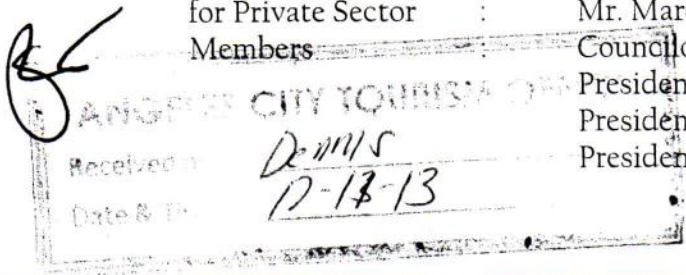
WHEREAS, Section 8 of the Angeles City Tourism Code calls for The Creation of a City Tourism Council chaired by the City Mayor;

NOW, THEREFORE, I, EDGARDO D. PAMINTUAN, Mayor of Angeles City, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CREATION OF THE ANGELES CITY TOURISM COUNCIL (ACTC)- The Angeles City Tourism Council (ACTC) is hereby created and shall act as the policy-making body of the City Government in the conceptualization and actualization of tourism related projects, as well as to assist in the processing of application of licenses of tour agencies, operations, tour guides, hotels, restaurants and other related institutions.

SECTION 2. COMPOSITION OF THE ANGELES CITY TOURISM COUNCIL. The ACTC shall be composed of the following:

SECTION 3. FUNCTIONS AND POWERS- The ACTC shall have the following functions and powers:

1. To undertake studies on natural resources and potentialities of the City of Angeles;
2. To formulate a comprehensive Tourism Development Plan for the City of Angeles in collaboration with the Department of Tourism and the Philippine Tourism Authority;
3. To initiate revenue-generating programs and projects such as cultural benefit shows including Buenas Angeles, the Sisig Festival and many more;
4. To accept donations from any and all sources for city tourism development; and,
5. To do any and all acts necessary, convenient or expedient to carry out the purpose for which the council is created and which are not in violation of any law.

SECTION 4. SECRETARIAT- The Angeles City Tourism Office (ACTO) Official shall serve as the Secretariat of the ACTC until such time that the ACTC can create a separate Secretariat funded through its own budget.

SECTION 5. FUNDING-The ACTC may raise funds from the private sector which shall accrue to a Trust Fund to be created by the City Government of Angeles through its Local Finance Committee. The said funds may only be used for ACTC approved activities or events.

SECTION 6. EFFECTIVITY-This Executive Order shall take effect immediately and supersedes previous issuances inconsistent herewith.
