**CREATING A TOURISM, TRADE AND INVESTMENT TASK FORCE
TO LAY DOWN THE FRAMEWORK FOR THE ANGELES CITY GOVERNMENT'S
ROADSHOW/BUSINESS MISSION TO CALIFORNIA, USA**

WHEREAS, Ordinance No. 301, S-2011 also known as the Angeles City Investment and Incentive Code, declares, as a general policy of the City Government of Angeles to attract investors, both local and foreign, by creating a good climate for investors, providing incentives for investments what will promote sustainable development, generate income and employment opportunities for the people of Angeles;

WHEREAS, the City Government recognizes the role of local tourism and trade as industries that may further be promoted abroad to encourage tourist arrivals, stimulate trade and attract investments to the city;

WHEREAS, a budget of P2Million has been earmarked for the conduct of an International Fair aside from possible additional budget from available funds of the Office of the City Mayor;

WHEREAS, the Department of Tourism has formally authorized the conduct of a fair in Los Angeles and San Francisco, USA;

WHEREAS, the National Government fully supports the development and full utilization of the Clark International Airport as a gateway to Northern Luzon;

WHEREAS, with the city's proximity to the airport, there is an opportunity to promote the city as an alternative tourist destination and business location to Filipinos living abroad as well as to other nationals interested to visit and invest in the Philippines;

NOW, THEREFORE, I, Edgardo D. Pamintuan, Mayor of Angeles City, by the powers vested in me by Republic Act No. 7160 otherwise known as the Local Government Code of 1991 do hereby order.

SECTION 1. CREATION OF THE TOURISM, TRADE AND INVESTMENT TASK FORCE. The Tourism, Trade and Investment Task Force shall be composed of the following:

SECTION 2. FUNCTIONS OF THE TOURISM, TRADE AND INVESTMENT TASK FORCE –
The Task Force shall perform the following functions:

- a. Determine the components and logistical requirements of the foreign mission;
- b. Recommend the members of the official delegation from the city government, the private sector and other agencies;
- c. Determine the roles and responsibilities of the members of the official delegation;
- d. Coordinate with the concerned Philippine agencies based in the venue/s for the activity;
- e. Coordinate with the different local stakeholders;
- f. Prepare a final concept paper for submission to the City Mayor for his approval and endorsement to the City Council;
- g. Perform other functions and responsibilities as may be authorized.


SECTION 3. MEETINGS. The Task Force shall conduct regular meetings to be attended by all members and shall be presided by the Chairman.

SECTION 4. BUDGET. The needed budget and logistical requirements of the Task Force shall be charged to available funds of the Office of the City Mayor.


SECTION 5. REPEAL CLAUSE – This Executive Order supersedes all previous issuances inconsistent herewith.
