ORDINANCE NO. 355, S-2014
(PO-802-10-14)

AN ORDINANCE DECLARING FIESTANG KULIAT AS THE OFFICIAL TITLE OF THE CITY'S MONTH LONG CELEBRATION OF THREE (3) FIESTAS DURING THE MONTH OF OCTOBER.

Whereas, the Local Government Code of 1991 RA 7160 mandates that every local government unit "shall ensure and support, within their respective territorial jurisdiction, the preservation and enrichment of culture."

Whereas, the Tourism Act of 2009 (RA 9593) "encourages activities and programs which promote tourism awareness, preserve the country's diverse cultures and heritage, and instill a sense of history and a culture of tourism among the youth and the populace"; (Chapter 1, Section 3.b)

Whereas, during the month of October three (3) fiestas are being celebrated in the City of Angeles, La Naval, Apung Mamakalulu and Feast of the Angels to preserve our local culture and heritage.

Now, Therefore, be it ordained by the Sangguniang Panlungsod of Angeles City in session assembled:

Section 1. That Fiestang Kuliat be the official title of the city's month long celebration of three (3) fiestas during the month of October wherein a series of activities are held.


Section 2. This Ordinance shall take effect upon its approval.






