Now, Therefore, Resolved as it is hereby resolved to coordinate and work with the Arts Section of the Plan/Policy Formulation and Programming Division of the National Commission for Culture and the Arts for the development and implementation of a worthy program for the establishment of a sustainable culture and arts program for the city be, as it is hereby, approved.




