Whereas, Ms. Jaclyn Jose is a versatile film and TV actress earning several awards from both local and foreign giving bodies for her memorable roles in films like *Salome*, *White Slavery*, *Santa Juana*, *Sana ay Ikaw Na Nga* in 2002, *Te Amo* in 2004, and *Dyosa* in 2008 with Anne Curtis;

Whereas, she is also known for a notable work in primetime soap opera, *Mula sa Pusong Hati tayo sa Magdamag*, *Babalik Kang Muli* and *Nagsimula sa Pusong*;

Whereas, Jaclyn Jose has been awarded as Best Supporting Actress by the FAP Awards in her role in *Naglalayag* in 2004 and *The Flor Contemplacion Story* in 1996;

Whereas, Ms. Jaclyn Jose is also a Gawad Urian Award in her role in *Sarong Banggi* in 2006, *Itanong Mo sa Buwan* in 1989 and *Takaw Tukso* in 1987;
